Mike Slavich commented on the title for the Animation-VFX Apprenticeship certificate. He voiced concern regarding the use of "apprenticeship" in a program coming before the council. Dr. Patricia Ramos echoed Mike's concern, indicating that apprenticeship programs would typically use a SAM code. Mike noted that the inclusion of apprenticeship in the title may be misleading to the student. He recommended that the college revisit the title for the program.
