The CEO determination regarding the Round 10 Strong Workforce Regional projects was:

- Fund the two highest-scoring projects in full.
- Distribute the remaining funding to colleges to allocate toward Core Initiatives.

Each LA-19 college will receive an additional \$90,287 to support Round 10 Core Initiative projects: Career Pathways, Job Placement, and Noncredit. Colleges may distribute funds across one or more initiatives to support the advancement of local workforce and CTE program priorities.

An updated communication with detailed guidance was shared by Dr. Makijan on October 8. Colleges must update their budgets to reflect this additional allocation by October 15, allowing sufficient time for review and follow-up before the October 31 CCCCO submission deadline. Please ensure your college completes the necessary updates by the deadline. If you have questions, feel free to reach out.

Invoices are due in MS Teams by **EOD Friday**, **October 31**, and should include encumbrance amounts to reflect spending progress.

- FY 2025-26, Quarter 1 invoices for Round 9 (24/25) projects are due by October 31, 2025.
- Project Budget Modifications (PBMs) to return Round 9 funds are due by January 31, 2026. The PBM process can be accessed here.
